7. Committee Reports

- a. Finance
 - i. Comments from guest Curt Newport included the village is on target at 50% of budget for income and expenses. Also good use of financial software.
- b. Planning and Zoning
 - i. None.
- c. Roads/Highways/Bridges
 - i. No culvert permits or rural access permits were issued.
 - ii. Two guests Stu Hanson, Hanson Professional Services and Curt Newport, Boone County Treasurer, spoke to the trustees on the seriousness of getting all the facts needed to make a decision on moving forward with the Orth road bridge. Stu Hanson recommended a complete replacement of this 1981 culvert bridge. The trustees continued discussions concerning repair, replacement and timeline with the guests.

Tentative Engineering planning general timelines include the following:

- Endangered Spike Mussel survey & mitigation Sept / Oct 2012
- Project Development plan & approvals late Dec 2012
- Phase I & II engineering completed early Feb 2013
- Bid letting process late Apr 2013
- Contract award and approvals early Jun 2013
- Begin bridge replacement mid-Jun 2013
- New bridge completed Oct / Nov 2013

Cost estimates have identified the following funds needed:

\$616,000 - Federal Bridge Fund

\$124,500 - Boone County Highway

\$124,500 - Timberlane Village

- iii. Motion made by Laura Herter and seconded by Donna Leone to approve funding of \$50,000.00 from the general fund in support of the Design Engineering Review contract with Hanson Professional Services and Civil Engineering Services for the disabled Orth road Bridge. - iv. Motion made by Laura Herter and seconded by Donna Leone to create a draft ordinance reducing the speed limit from 45 MPH to 35 MPH on Dawson Lake rd within village limits. Vote ayes: Donna Leone, Laura Herter, Steve Rapp (tie breaker), Nay's: Bob Marner, Ron Stelling, Absent: Dixie Timmerman.

- v. Motion made by Ron Stelling and seconded by Laura Herter to approve the purchase of batteries not to exceed \$50.00 for warning flasher lights. Vote all ayes, 0 nays, 1 absent
- vi. Ron Stelling will investigate costs of seal coating and shoulder repair on Dawson Lake rd.
